Fig. 1. Total PCMH Providers in NYS by Practice Type Changes between July 2013 and May 2017

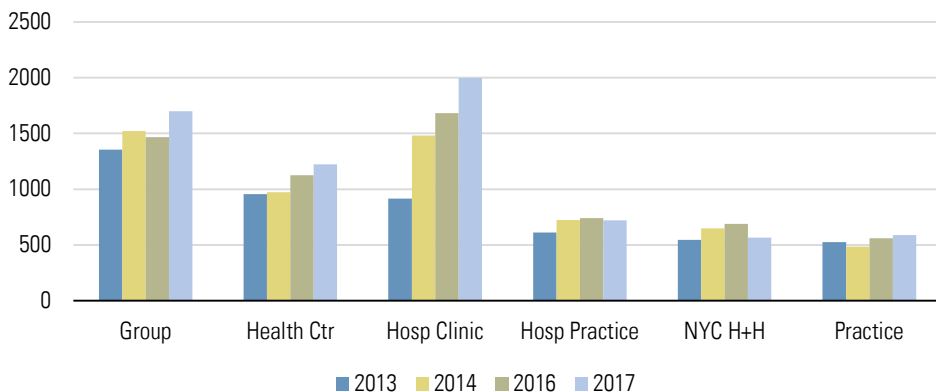


Fig. 2. Subtotal, Non-NYC PCMH Providers by Practice Type Changes between July 2013 and April 2016

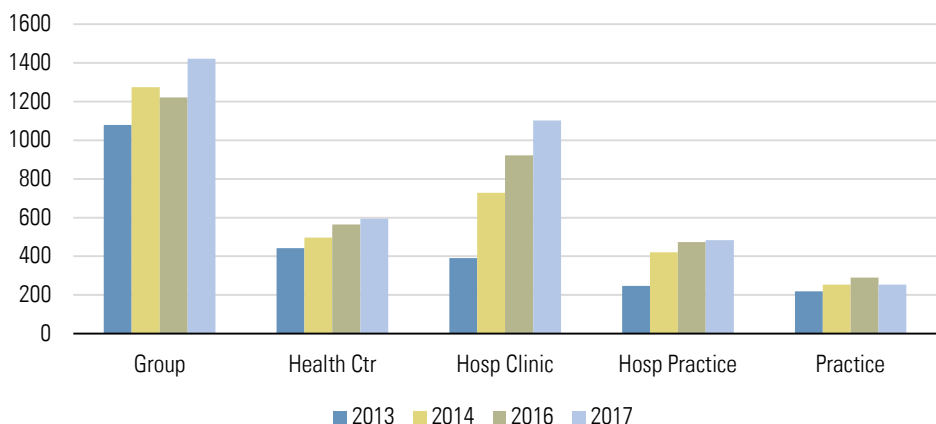


Fig. 3. Subtotal, NYC PCMH Providers by Practice Type Changes between July 2013 and May 2017

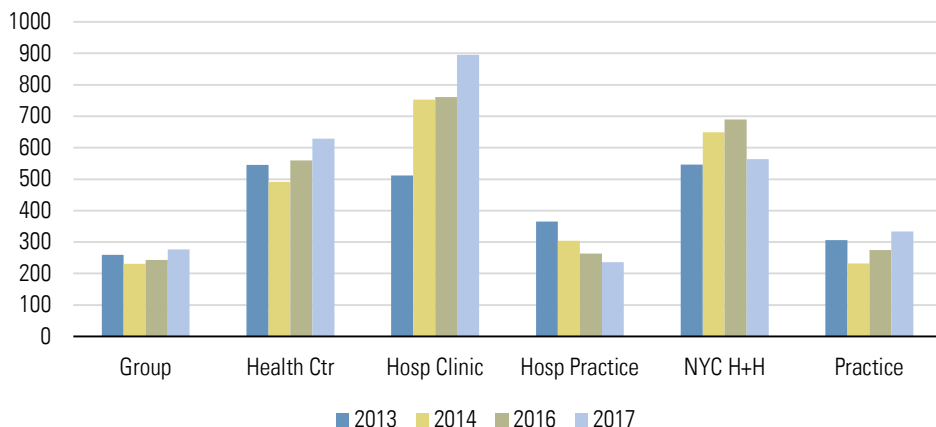


Fig. 4. Capital Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

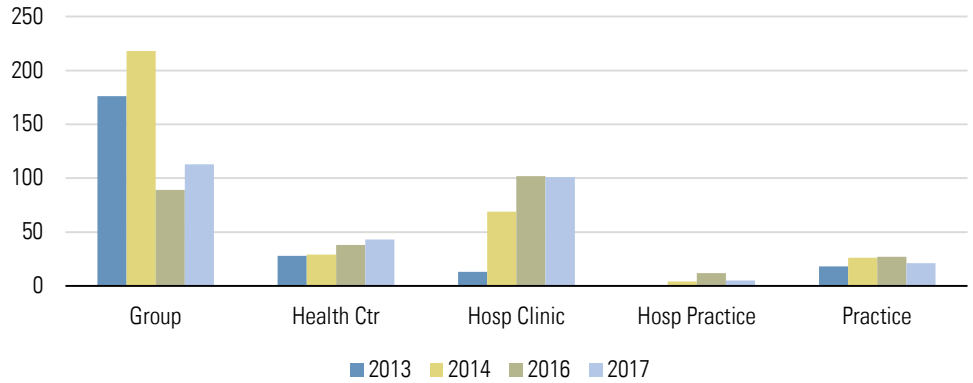


Fig. 5. Central Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

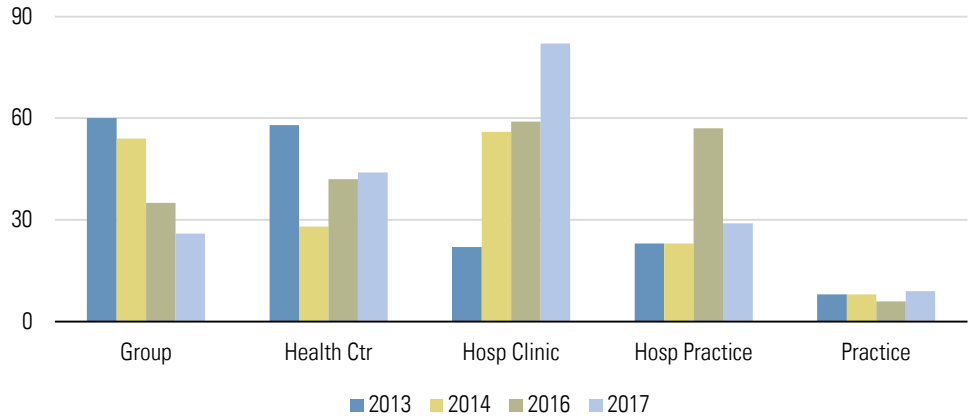


Fig. 6. Finger Lakes Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

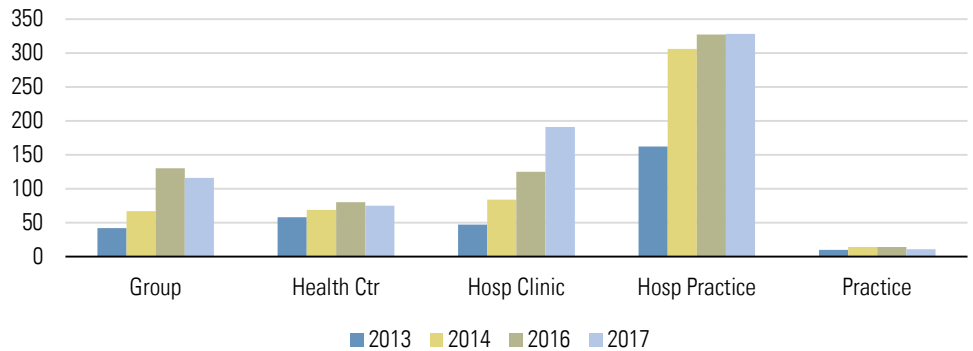


Fig. 7. Long Island Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

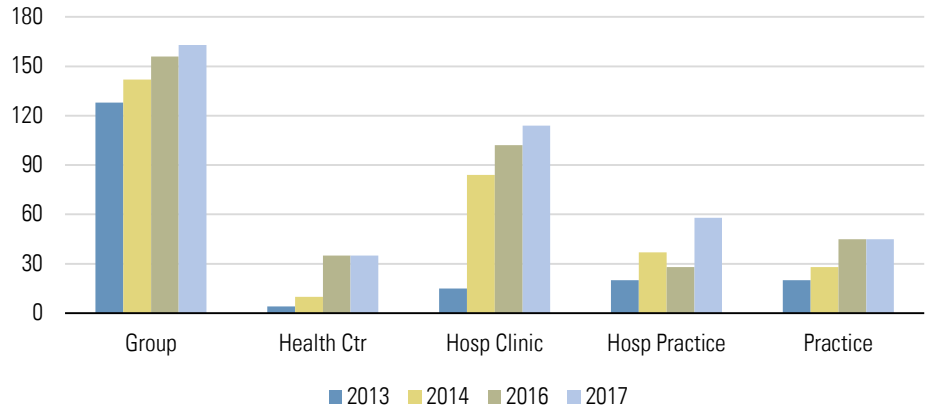


Fig. 8. Mid-Hudson Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

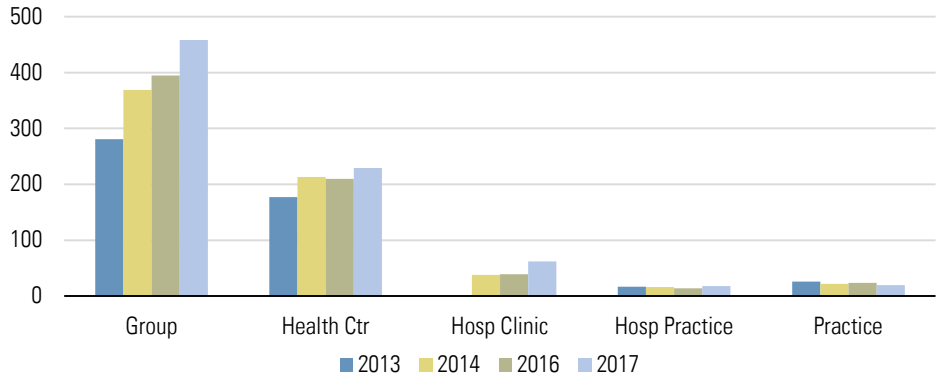


Fig. 9. Mohawk Valley PCMH Providers by Practice Type Changes between July 2013 and May 2017

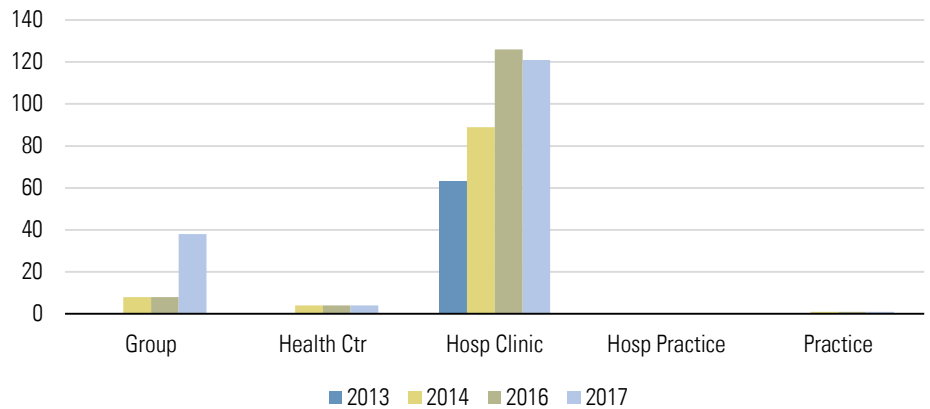


Fig. 10. North Country PCMH Providers by Practice Type Changes between July 2013 and May 2017

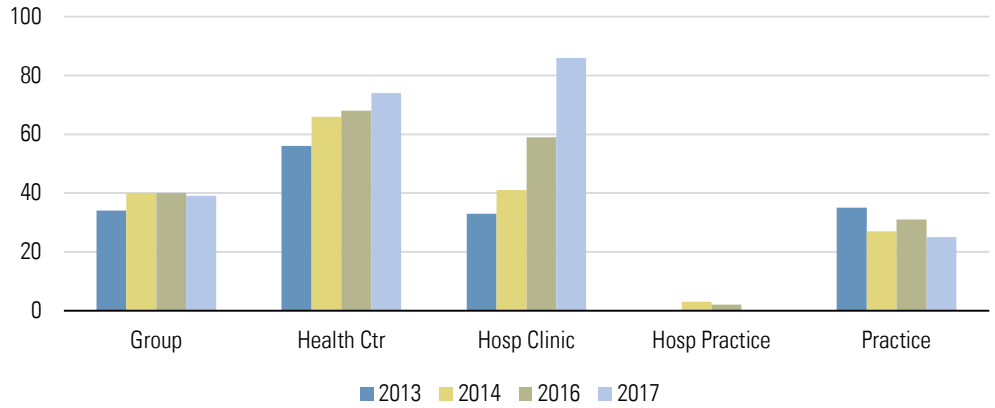


Fig. 11. Southern Tier Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

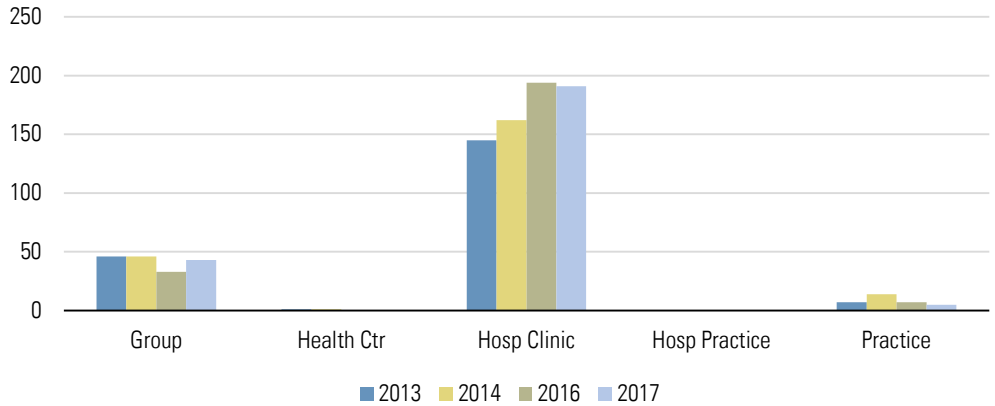


Fig. 12. Tug Hill Seaway Region PCMH Providers by Practice Type Changes between July 2013 and May 2017

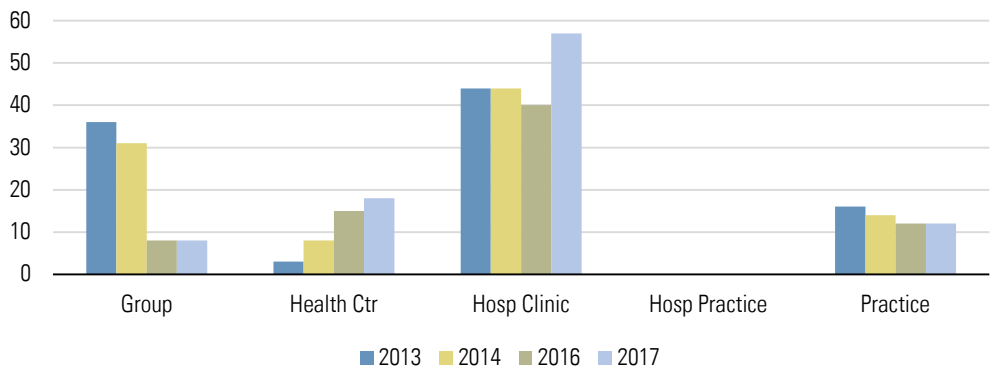


Fig. 13. Western New York PCMH Providers by Practice Type Changes between July 2013 and May 2017

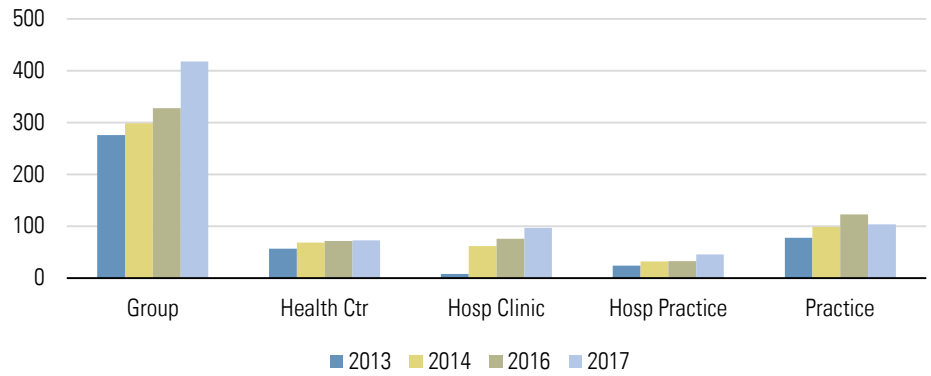


Fig. 14. Subtotal, NYC PCMH Providers by Practice Type Changes between July 2013 and May 2017

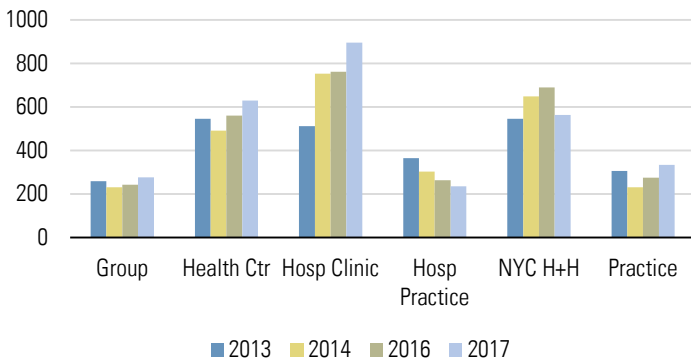


Fig. 15. Change in PCMH Providers in NYC, by Borough, 2013 to 2017

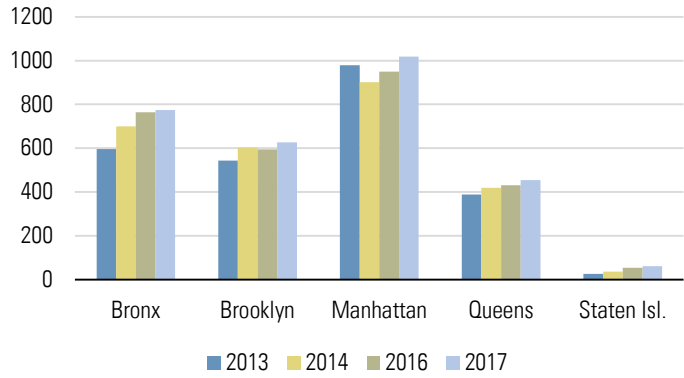


Fig. 16. The Bronx PCMH Providers by Practice Type Changes between July 2013 and May 2017

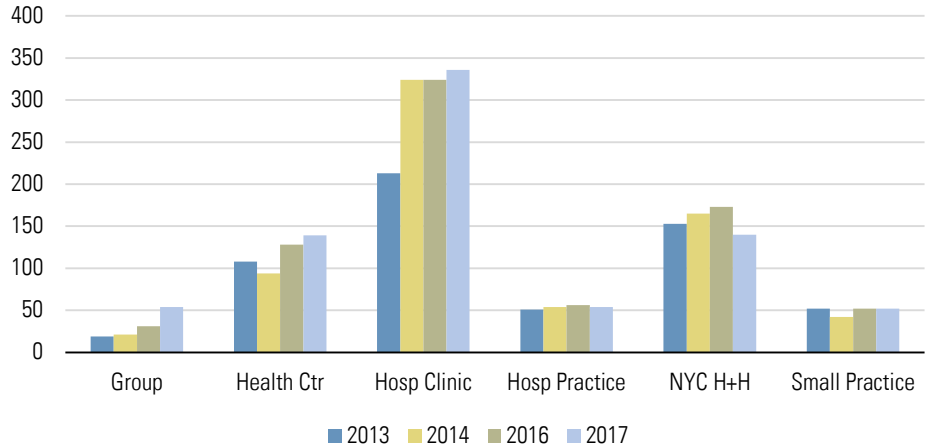


Fig. 17. Brooklyn PCMH Providers by Practice Type Changes between July 2013 and May 2017

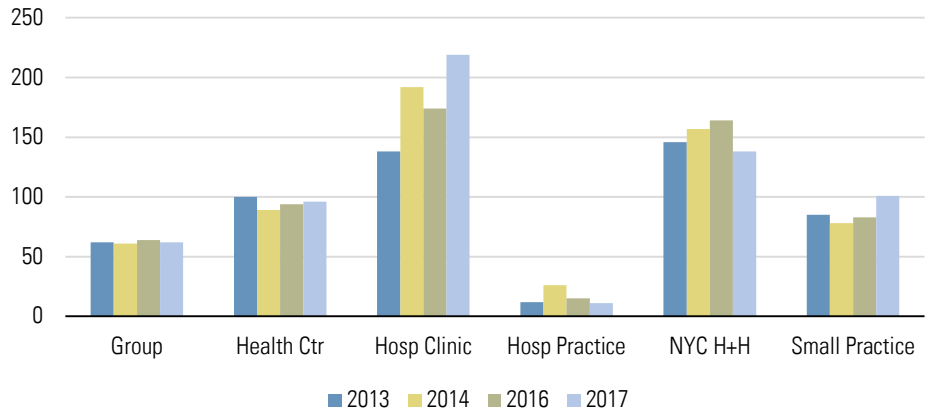


Fig. 18. Manhattan PCMH Providers by Practice Type Changes between July 2013 and May 2017

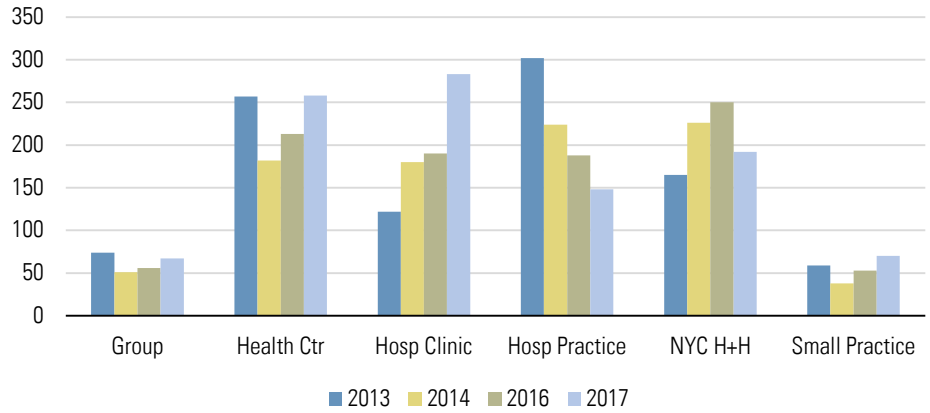


Fig. 19. Queens PCMH Providers by Practice Type Changes between July 2013 and May 2017

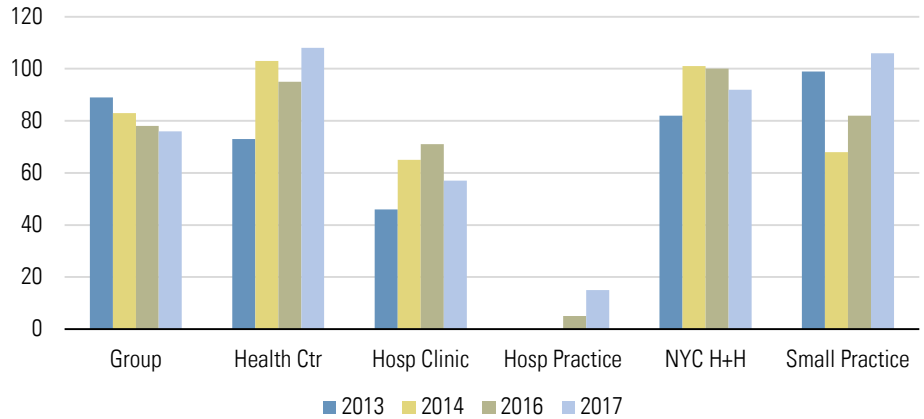


Fig. 20. Staten Island PCMH Providers by Practice Type Changes between July 2013 and May 2017
